

VIOLENT DEATH IN NORTH CAROLINA: ROBESON COUNTY INCIDENTS. 2013-2022

The North Carolina Violent Death Reporting System (NC-VDRS) is a CDC-funded statewide surveillance system that collects detailed information on violent deaths that occur in North Carolina, including: homicide, suicide, unintentional firearm deaths, legal intervention, and deaths of undetermined intent. NC-VDRS triangulates information from death certificates, medical examiner reports, and law enforcement reports to understand and aid in the prevention of violent deaths. Data reported in this document are based on the county where the death occurred rather than county of residence. 
¹The occurrent ratio is used instead of the rate. This statistic is derived from the total number of violent deaths resulting from injuries in a specified geographic region divided by the number of residents in the region.




- For the years 2013-2022, there were 496 violent deaths from injuries sustained in Robeson County. Of these 496 deaths, 481 were NC residents (97.0%) and 453 were Robeson County residents (91.3%).
- There were 156 suicides (31.5%), 317 homicides (63.9%), six unintentional firearm deaths (1.2%), five deaths from legal intervention (1.0%), and 12 deaths of undetermined intent (2.4%).

• In Robeson County, the suicide ratio was 8.5 times higher in males than in females, and the homicide ratio was 4.8 times higher in males than in females.

Manner of Death by Race/Ethnicity: Robeson County, NC: NC-VDRS, 2013-2022*





- The suicide rate was highest for non-Hispanic (NH) White victims (25.8) suicides per 100,000 population) followed by NH American Indian victims (13.3 per 100,000).
- In contrast, the homicide rate was highest among NH Black victims (39.3 per 100,000 population) followed by NH American Indian victims (30.3 per 100,000).



- Suicides and homicides displayed dissimilar age patterns. Homicide rates peaked among those aged 20-24 with 60.6 homicides per 100,000, while suicide rates peaked among those aged 75-84 with 26.0 suicides per 100,000.
- More than three quarters of homicides (85.5%) and almost two thirds of suicides (62.8%) involved firearms.
- Suspicion of intoxication was reported in 12.0% of homicides and 12.8% of suicides.
- For homicide incidents where one or more suspects were identified, the relationship of the victim to the suspect was known (current or former spouse/boyfriend/girlfriend, family, friend or acquaintance) more frequently for female (65.5%) than for male (50.2%) victims.



- Twenty percent (20.2%) of male and 20.0% of female Robeson County suicide victims with circumstance information were characterized as being currently depressed when they died by suicide.
- Sixty-seven percent (66.7%) of female and 41.1% of male suicide victims were characterized as having a current mental health problem.
- Females (6.7%) were more likely to have attempted suicide in the past as compared to males (9.3%).
- *Based on the county of injury occurrence, 92.3% of cases had circumstance information. Three females and nine males were missing circumstance information.




- *Based on the county of injury occurrence, 88.3% of cases had circumstance information. Six females and 31 males were missing circumstance information.
- † There were fewer than 5 deaths

- Arguments or conflicts were more likely to be a contributing factor for male homicides (48.3%) than for female homicides (38.5%).
- Thirty-three percent (32.7%) of female homicides and 32.5% of male homicides were precipitated by another crime such as robbery, burglary, or drug trafficking.
- Intimate partner violence was a contributing factor in 36.5% of female homicides, but only 10.1% of male homicides.
